Seeing the Police party all persons tried to flee away, but we were able to apprehend 11 (eleven) of them. I asked the reason about their gathering in the locality, but they did not give any satisfactory answer as well as they did not wear any mask or any other clothing covering their mouth and nose in public place as per Govt. order vide No- 647-ISS/2M-22/2020 dated- 15.05.2021 read with No- 707-ISS/2M-22/2020 dated- 29.05.2021 and Order No- 753-ISS/2M-22/2020 dated- 14.06.2021 of the Government of West Bengal and they violated the order.

As such they have committed offence u/s – 188/34 IPC & 51 (b) of Disaster Management Act – 2005. Since the offence u/s – 188 IPC is cognizable and they did the offence in presence of Police. Hence, I arrested them after maintaining all guidelines of Hon'ble Apex Court regarding arrest.
