I, ASI Nimai Rajwar of Kenda PS, Dist- Purulia in producing herewith the following accd. Persons namely (i) Kartick Mahato (24 Yrs), S/o- Fatik Mahato of Vill- Bijoydih, PS- Kenda, Dist- Purulia (ii) Gurupada Sing Sardar (22 Yrs), S/o- Fakir Sing Sardar of Vill- Bijoydih, PS- Kenda, Dist- Purulia (iii) Tapas Majhi (21 Yrs), S/o- Bhutu Majhi of Vill- Ulda, PS- Barabazar, Dist- Purulia (iv) Akash Mahato (21 Yrs), S/o- Pran Krishna Mahato of Vill- Turang, PS- Kenda, Dist- Purulia and (v) Chunaram Mahato (25 Yrs), S/o- Brindaban Mahato of Vill- Kantasiari, PS- Tamna Dist- Purulia and do hereby lodge a written complaint against them to the effect that today on 19/06/2021, as per direction while I along with C/1255 Ajoy Bauri & HG/1933 Lakhindar Mura both of Kenda PS engaged in evening mobile duty at Kenda PS area. While we reached near Keshya Morh at about 16.55 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection or disease dangerous to human life and violated Government rule. I offered them for medical checkup but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
