Sir,

In producing here with 02 (Two) arrested accused persons namely (1) Sunil Soren (32) s/o Bhutru Soren of village- Chandra, PO- Supururi, PS- Bandwan, Dist- Purulia (2) Umer Hansda (23) s/o Sefal Hansda of vill+PO- Jamtoria, PS- Boro, Dist- Purulia.

I beg to state that today (07.06.2021) at 14:05 hrs. I was directed to find out whether the Pandemic situation of Covid - 19 has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No-.222 Dtd. 07.06.2021 . Accordingly, I had been to Barapul village side and found that, above noted persons driving one bricks loaded Truck having registration No- WB 33D/0032 was coming towards Pairachali side from Manbazar side. I detained the Truck at Barapul under Manbazar PS and after demanding, he failed to produce any documents for plying such vehicle though there is specific direction of prohibition by the competent authority during such Covid – 19 pandemic situations.

As such I seized one Bricks loaded Truck loaded approx 3000 pieces bearing registration No- WB 33D/0032 driven by Sunil Soren (32) s/o Bhutru Soren of village- Chandra, PO- Supururi, PS- Bandwan, Dist- Purulia and bring the vehicle to PS and also arrested accused driver namely Sunil Soren observing all formalities.

All the process was done in between 14:55 hrs to 15:15 hrs. After that I left for PS. On arrival at PS I typed this complaint by PS computer and submitted to OC Manbazar PS through duty officer S.I. Mahadeb Rana for taking necessary action as per law.
