Then at 12.05 hrs received a credible source information that large scale theft of sand is continuously going on from Horakrishnapur ghat at Kongsaboti River bed since few days. I passed information to O.C Manbazer P.S to support extra officer and force for working out the information. Thereafter S.I Sanjib Chatterjee along with CV boys team joined with us. Being arrived at Horakrishnapur river bed found the above-mentioned Tractor illegally loaded with sand were coming in a row and the sand lifting from Horakrishnapur river bed by the above
