Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Bikky Nunia (19Y) S/O- Lala Prasad Nunia of Vill-Nunia Basti, Sanctoria, PS-Kulti, Dist-Paschim Burdwan along with one seized Bolero Pick-up vehicle bearing registration No- WB 81/1548 loaded with 01 MT (Approx) raw coal, do hereby lodge a complaint to the effect that on 01.06.2021 I, SI Sujoy Kundu, along with C/1260 Santosh Soren, C/ 939 Laltu Paul and C/1353 Atanu Ganguly all are of Neturia PS were engaged in night mobile duty & Naka duty vide Neturia PS GDE No- 36 Dt. 01.06.2021 & CC No- 1457/21 Dt. 01.06.21. In course of Night mobile duty & Naka checking at about 22:05 hrs reached at D-Ghat Police Naka Checking Point (SH-5) Purulia -Barakar pitch road and started Naka checking. In the mean time at about 22:55 hrs found that the above noted vehicle was coming from Asansol side. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside of the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle and owner of coal have procured said coal from different illegal coal mines at different area.

So, it is reasonable to believe that the above noted accused driver, registered owner of the said vehicle and owner of coal have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly, I seized Bolero Pick-up bearing registration No- WB 81/1548 loaded with raw coal of 01 MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Bikky Nunia (19Y) S/O- Lala Prasad Nunia of Vill-Nunia Basti, Sanctoria, PS-Kulti, Dist-Paschim Burdwan (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded Bolero Pick-up. During interrogation accused driver stated that the owner of the said vehicle is Subhas Kumar Shaw but he could not disclosed the name and address of the said coal owner. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on that spot.

Under the above circumstances a specific case may kindly be started against 1) Bikky Nunia (19Y) S/O- Lala Prasad Nunia of Vill-Nunia Basti, Sanctoria, PS-Kulti, Dist-Paschim Burdwan (Driver) (2) Subhas Kumar Shaw of Adra, registered owner of vehicle having No- WB 81/1548 and (3) Owner of coal seized from vehicle No- WB 81/1548 under proper section of law.
