Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Inglesh Kumar Singh (51) S/O- Bharosa Singh of Vill-Aganoor, PS- Kaler Agnur, Dist-Arwal, Bihar, A/P- Vill-Kuthibari, PS- Neturia, Dist-Purulia with seizure of 19 pcs Sealed bottles of Captain Country spirit containing 600 ml each and one motorcycle having registration No- JH 10AE/1269 which were seized under proper seizure list.

I beg to submit that today (18.06.21) while I, SI Chandan Kumar Sen along with C/1304 Dhananjay Mandal, C/939 Laltu Paul and C/1260 Santosh Saren were performing day mobile duty vide Neturia PS CC No- 1594/21 & GDE No-719 Dt. 18.06.21. I received a source information that one person was selling liquor with the help of motorcycle having No- JH 10AE/1269 at Rangdih village, accordingly acting on source information after consulting you at about 14:25 hrs reached at Rangdih village and intercepted the above noted accused with his motorcycle and on being search found one bag is hanging on motorcycle loaded with 19 pcs Sealed bottles of Captain Country spirit containing 600 ml each. On demand Inglesh Kumar Singh failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents and he also failed to produce any valid documents in respect of motorcycle having registration No- JH 10AE/1269. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 19 pcs Sealed bottles of Captain Country spirit containing 600 ml each and one motorcycle having registration No- JH 10AE/1269 were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Inglesh Kumar Singh (51) S/O- Bharosa Singh of Vill-Aganoor, PS- Kaler Agnur, Dist-Arwal, Bihar, A/P- Vill-Kuthibari, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Inglesh Kumar Singh (51) S/O- Bharosa Singh of Vill- Aganoor, PS- Kaler Agnur, Dist-Arwal, Bihar, A/P- Vill-Kuthibari, PS-Neturia, Dist-Purulia under proper section of law.
