In producing herewith 04 (Four) arrested accused persons namely (1) Bikanta Khawash (26) S/O- Dhananjoy Khawash of Vill-Nabagram (2) Koushik Roy (27) S/O- Swapan Roy of Vill-Narayanpur (3) Bhim Kumbhakar (27) S/O- Manbodh Kumbhakar of Vill-Puapur and (4) Naren Gope (27) S/O- Sagar Gope of Vill-Chalmara all are under PS-Neturia, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 25.06.2021 while I, SI Abhijit Das, along with C/1224 Gajan Murmu and NVF/578 Niranjan Hembram both of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 998/21 and CC No- 1648/21 dated 25.06.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Sarbari More at about 14:25 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Sarbari More but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
