Sir,

I, Gauraj Bishwakarma & Lt. Natesh Bishwakarma of Parbelia bazar, P.S. Neturia, Distt Purulia would like to inform you on 28/6/2021 at about 1:45 AM when I was sleeping in my house, heard a loud noise outside my house and I wake up. Hearing the noise I came out from my house and saw that the night mobile van of Neturia P.S. has detained one white colour bolorosa vechile at a little distance from my house. I came to the vechile and found that the vechile is having registration no. WB/38AD-4048 and total 10 numbers of battery was loaded in the vechile. From the on duty police personal I came to learned that some unknown miscreants have committed theft at a reliance mobile tower which is situated at about two hundred metres ^{from my house} and stole away all the batteries of the mobile tower. then I along with police went to the mobile tower and found that the miscreants stole away all the batteries after breaking the lock of the battery room.

I, therefore, pray to take necessary legal action from your end to detect the case
