Complain for starting a specific case. Sub:-

Sir.

In producing herewith one arrested accused namely Shraban Mudi (31) S/O- Lt. Sudhakar Mudi of Vill-Keliasota, PS-Neturia, Dist-Purulia (Driver of tractor No- WB 81/0794) and 02 (Two) seized tractor along with trolley having registration No- WB 81/1155, Chassis No-MBNABAJAKHRK00701 & Engine No- RHK2KBA0157 and having registration No- WB 81/0794. Chassis No- RFNE05123, Engine No- RFNE05123 loaded with sand in both tractor approx 100 eft each under proper seizure list. I beg to submit that I. SI Abhijit Das along with C/1224 Gajan Murmu and NVF/1051 Biswajit Mahato all are of Neturia PS were performing day mobile duty vide Neturia PS CC No- 1682/21 Dt. 29.06.2021 and at about 15:45 hrs received a credible source information that two tractors were coming from Maheshnadi side towards Sarbari side loaded with sand illegally. Accordingly I intimated the matter to you over R.T. and as per your direction; we started Naka checking at Puapur More to intercept the above noted tractors and at about 16:05 hrs found the above noted tractors were coming from Maheshnadi side but the vehicles suddenly stopped 70/80 meter away from us and one person from each vehicle seems to be the drivers of the vehicle got down from the vehicle and started running. We chased to apprehend the person and in spite of hot chase we managed to apprehend the above noted person but another one managed to flee away. Then we searched the vehicles and found that the vehicle (Tractor) having registration No- WB 81/1155 and WB 81/0794 have been loaded with sand approx 100 Cft. On being asked the detained driver, failed to produce any relevant documents in respect of loaded sand as well as failed to produced vehicle related documents and on interrogation he stated that one Dayamoy Mondal S/O- Laxmikanta Mondal of Vill- Lalpur, PS-Neturia, Dist-Purulia is the registered owner of the above noted both vehicles.

So, there is reason to believe that the driver of both vehicles and registered owner of the both vehicles have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen, as per their regular practice.

Accordingly I seized both the Tractors bearing No WB 81/1155 and WB 81/0794 along with trolley loaded with sand approx 100 C.Ft. in each tractor under proper seizure list duly signed by witnesses and arrested the above noted accused driver after maintaining all formalities of Hon'ble Apex Court of India. So, the drivers of both tractors and registered owner of the both tractors have committed offence U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver of Tractor No- WB 81/0794 namely Shraban Mudi (31) S/O- Lt. Sudhakar Mudi of Vill-Keliasota, PS-Neturia, Dist-Purulia, driver of Tractor No- WB 81/1155 and registered owner the both tractors namely Dayamoy Mondal S/O- Laxmikanta Mondal of Vill- Lalpur, PS-Neturia, Dist-Purulia U/S-379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
