Sub:- Complaint regarding Fake Application on Rupashree Prakalpa

This is to inform you that an application of Sar Banu was submitted on 22-02-2021 to the office of the undersigned regarding Rupashree Prakalpa. At the time of hearing the following points have been revealed:-

- 1) Date of Marriage has been written on the application as 14-03-2021. But the applicant was already married five years ago and she has two children.
- 2) The guardian of the applicant has been summoned today for verification of his documents. When he has been asked about his identity, he declared himself as applicant's brother. According to him, Sar Banu (Applicant) is his sister and Sk. Mahiuddin is his father. But one staff of the office of the undersigned has identified the person as Sk. Samsed (S/o-almahammad) who is the husband of the applicant.
At last Sk. Samsed has admitted himself as the husband of the applicant (Sar Banu) and Sk. Mohiuddin is his father-in-law. He married to Sar Banu five years ago.
- 3) After verification of the submitted documents it has been revealed that One witness, Sk. Nasim has given written declaration that he has not provided any documents as witness. The document is fake and also the other documents of the rest witnesses are fake.
- 4) It has also been observed that i) Sk. Salemahammad ii) Sk. Neyamuddin iii) Sk. Alauddin iv) Sk. Sarfuddin v) Sk. Nasim are the witnesses in many applications i.c.w Rupashree Prakalpa
- 5) It has been presumed that some persons may involve with the aforesaid illegal activities.

You are requested to make an enquiry about the matter and take necessary action against the persons who have involved in these illegal activities.
