Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 18.15 hrs to 18.45 hrs I held raid in the house of Chittaranjan @ Raju Chakraborty (21yrs) S/o Haradhan Chakraborty of Village - Nadiha, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license. So I seized 18 (Eighteen) bottles of 'DIL KHUSH' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them.
