Sir,

In producing herewith the 04 (four) arrested accd persons namely (1) Babujan Tudu @ Babu Kora (30yrs) S/O Lt. Kinkar Tudu (2) Ganesh Maddi (28yrs) S/O Lt. Bhuta Maddi (3) Nripen Hembram (22yrs) S/O Lt. Mangla Hembram (4) Tapan Baskey (35yrs) S/O Sona Baskey all of vill- Bepari Potapara, Sirisdanga, PO- Nandi, PS- Jamuria, Dit- Paschim Burdwan with one truck having Reg. No WB37A/1785 loaded with bricks (constructional material).

I beg to state that today (01.06.21) morning at 11.25 hrs I was engaged to perform Naka duty at Gadapathar Naka point (inter district) to implement the govt direction regarding Covid-19. This refers to Puncha PS GDE No.04 dtd. 01.06.21 During Naka at Gadapathar Naka lies under Puncha PS jurisdiction. I detained a truck (Reg No. WB37A/1785) loaded with bricks (4000 pcs approx) which was coming from Bankura side. After demanding the driver could not able to produce any documents for plying such vehicles as well as D/L and other documents of vehicle through this road yet there is specific direction of prohibition by the competent authority during such Covid- 19 pandemic situation (Memo No-486-CS/2021 Dated-24th April, 2021).

As such I seized the bricks loaded truck bearing Reg No WB37A/1785 as per proper seizure list and arrested the driver of vehicle bearing Reg No WB37A/1785, namely Babujan Tudu @ Babu Kora along with above noted 03 (three) others (labour) observing all formalities as per law and bring that vehicle and accd person in the PS.

On arrival I am submitting a complaint to start a specific case against (1) Babujan Tudu @ Babu Kora (30yrs) S/O Lt. Kinkar Tudu (2) Ganesh Maddi (28yrs) S/O Lt. Bhuta Maddi (3) Nripen Hembram (22yrs) S/O Lt. Mangla Hembram (4) Tapan Baskey (35yrs) S/O Sona Baskey all of vill- Bepari Potapara, Sirisdanga PS- Jamuria, Dit- Paschim Burdwan and (5)Registered owner of truck no.WB37A/1785 in appropriate section of law.
