I the undersigned would like to inform you that my wife Smt. Nita Verma, W/o. Sri Manoj Barma @ Verma, D/o. Late. Ashok Verma, at present residing at Haripada Dan Road, Purulia Municipal Ward No. 12, P.O- Namopara, P.S- Purulia (T), District – Purulia, West Bengal, PIN- 723103 in a separate accommodation as she often used to inflict physical as well as mental torture upon me and I have been deserted, for which I have filed a divorce suit against her, which is pending before the Ld. District Judge, Purulia. After filing of the suit she used to make quarrel in a routine manner at the instigation of Bijendra Rewani, Kinkar Rewani, both are son of Krishna Rewani, and Manoj Verma, S/o- Late Ashok Verma, all are resident of Vill + P.O- Anara, P.S- Para, Dist- Purulia. On 21.06.2021 at about 3:15 after completion of my work when I reached home I saw Nita Verma assaulting my niece namely Khushbu Verma, D/o- Manup Kumar Verma, by fist and blows and thereafter she pushed my niece as a result she fell down on the floor and Nita Verma tries to kill her by throttling, being seated on her chest and when I tried to save my niece I was also badly assaulted by a lathi, thereafter said Nita Verma went to the 1st floor of the building and by breaking a bottle chased me in order to commit murder. Seeing such activity I somehow escape from the place, and at that time she shouted by saying that "Sala divorce Chahiye? Tumko aur tumhare parivaar ko Jaan se maar denge agar mujhe ek Flat aur 10,00,000/- rupiya nahi diya toh".

Under the circumstances set forth above it is crystal clear that said Nita Verma assaulted my niece and try to commit murder of myself and my other family members. In this regard you are requested to take appropriate legal action against the wrongdoer.
