Sir.

I, SI Sk. Afiruddin of Purulia (T) PS, do hereby lodge a suo moto complaint against (1)Surajit Mitra, S/o - Lt. Dinu Mitra of- Garikhana near Duragamandir, P.S - Purulia(T), Dist -Purulia, (2)Kakali Das, D/O- Sadhu Das, of – Bhatbandh P.S – Purulia(T), Dist -Purulia (3) Nilatpal Singha, s/o-Ramnarayan Singha of vill-Napara, PS-Puncha, Dist-Purulia, A/P Amdiha, near Sisusikha Niketan , under Purulia(T) PS, Dist-Purulia, (4) Joydipta Chattaraj, s/o- Lt Mrinal Chattaraj of Sarat Sen Compound , near Mahato Bandh, PS-Purulia (T), Dist-Purulia and others to the effect that today i.e., on 31.05.2021 at about 09:00 hrs while I was on patrolling duty near Hater More under Purulia (T) PS jurisdiction I noticed that the above noted persons gathered with a banner of BJP and were performing political program, without maintaining social distancing, defying the latest order of partial lockdown issued by Govt. of West Bengal in view of ongoing pandemic situation vide Order No. 647-ISS/2M-22/2020 dtd. 15/05/2021 and Order No.707-ISS/2M-22/2020 dtd.29/05/2021.

The relevant portion of Order No. 647-ISS/2M-22/2020 dtd. 15/05/2021 and Order No.707-ISS/2M-22/2020 dtd.29/05/2021 are as follows:-

SI. No.12 of Order No. 647-ISS/2M-22/2020 dtd. 15/05/2021 states that "All administrative, academic, entertainment, political, cultural, and religious gatherings, groupings and congregations shall be prohibited." and the fourth para of the Order No.707-ISS/2M-22/2020 dtd.29/05/2021 says that "Now, after consideration of the recommendations of the State Executive Committee of West Bengal State Disaster Management Authority, restriction measures as notified in aforesaid orders stands extended upto 6 PM of Tuesday 15th June 2021, with following additional clarification."

I asked the above noted persons as to why they have violated the latest order of Govt. of West Bengal issued in view of ongoing pandemic situation? But they failed to give any proper account about my query. Their activity clearly reflects that they have intentionally violated the above referred order.

As the above noted accd. persons have violated the Govt. order attracting the section 51(1)(b) of National Disaster Management Act 2005 and 188/34 of IPC, I am submitting suo moto complaint against the above noted accd. persons.

Therefore, I pray before you to start a specific case against the above noted persons under proper section of law and to arrange for its investigation.
