Sir,

In producing herewith the arrested accused person namely Pintu Sahis (42 Yrs) s/o Lt. Jatal Sahis of Deshbandhu Road bye Lane, near Perkabandh, Ward No 01, PS Purulia (T), Dist Purulia under arrest memo alongwith seized article namely 20 (twenty) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 600 ml of country spirit having strength 80°UP being sealed properly) blended and bottled by Singh Fisher. N Vill Kalipur, PO Simulia, Dist. Purulia, Pin 723102 and 14 (forteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80°UP being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149 under proper seizure list and being labeled properly, I, PLSI Sumana Kar, beg to report that while I was performing special mobile duty vide CC No.1541/21 dtd.06.06.21, at about 20:15 hrs near Alangidanga received a secret telephonic information from source that one person namely Pintu Sahis (42 Yrs) s/o Lt. Jatal Sahis of Deshbandhu Road bye Lane, near Perkabandh, Ward No 01, PS Purulia (T), Dist. Purulia was selling country spirit at his house illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/2117 Goutam Lohar, C/3192 Tarun Sahoo, C/2365 Sourav Kr. Sau and NVF/188 Arup Kr. Mahato all of Purulia (T) PS proceeded to work out the information.

After sometime we reached near Perkabandh, keeping our Govt. vehicle at a reasonable distance we proceeded towards the house of Pintu Sahis near Perkabandh as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons inside his courtyard and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation the said person disclosed his identity as Pintu Sahis (42 Yrs) s/o Lt. Jatal Sahis of Deshbandhu Road bye Lane, near Perkabandh, Ward No 01, PS Purulia (T), Dist Purulia. On search of the house we found 20 (twenty) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 600 ml of country spirit having strength 80°UP) blended and bottled by Singh Fisher. N Vill Kalipur, PO Simulia, Dist. Purulia, Pin 723102 and 14 (forteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80°UP) blended and bottled by Purulia Bottling Pvt. Ltd.,

Vill+ PO Lagda, Dist. Purulia, Pin 723149. On further interrogation Pintu Sahis stated that the said place was his residence and was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit. As such at about 20:45 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and sealing properly. I also took samples and arrested him observing all the formalities as the said person committed an offence which attracts sec. 46 of B.E. Act 1909.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
