Respected Sir,

In producing herewith 01 (One) arrested accused person namely Jitendra Jaiswal (39) S/o Lt. Jokhanlal Jaiswal of Karpur Bagan, Ward No 21, PS - Purulia (T), Dist.- Purulia along with one pick up van having Reg. No. WB 37B/8226 loaded with approx 275 Kgs. Aluminum wire coated with black plastic.

I beg to report that today i.e. on 01.06.2021 at about 12:25 hrs during my day mobile duty with C/140 Subrata Banerjee and HG/1789 Thakurdas Bauri vide Raghunathpur PS CC No. 1137/2021 dated 01/06/2021, I received a credible source information that one pick up van bearing Reg. No. WB 37B/8226 was coming from Santaldih side via Santaldih - Raghunathpur pitch road loaded with Aluminum wire and may proceed towards Asansol side for selling the same. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we had been to Gobranda more on Chelliyama - Raghunathpur pitch road and started Naka Checking.

At about 12:55 hrs one pick up van having Reg. No. WB 37B/8226 was intercepted at the Naka Point and on searching the vehicle as well as found aluminum wire was loaded with huge quantity. On asking driver namely Jitendra Jaiswal (39) S/o Lt. Jokhanlal Jaiswal of Karpur Bagan, Ward No 21, PS - Purulia (T), Dist.- Purulia of the said vehicle failed to produce any papers in respect of said aluminum wire as well as papers in respect of the said pick-up van. After repeated interrogation, he admitted that the vehicle loaded with aluminum wire was a stolen one procured by them by committing theft from Santaldih. He also confessed before all of us that, they are professional and have stolen away many aluminum wire form different places under the leadership of Chiranjit @ Jhony Sen S/o Astik Sen of Tantipara, Ward No 2, PS - Raghunathpur, Dist.- Purulia and others.

So, it is reasonable to believe that the driver and one Chiranjit @ Jhony Sen collected the said aluminum wire either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. On interrogation he confessed his guilt. As such it is every reason to believe that the driver and one Chiranjit @ Jhony Sen transporting aluminum wire illegally. As such I arrested him after observing all formalities and narrating him the ground of arrest. I also seized the pick-up van having registration No. WB 37B/8226 loaded with approx 275 Kgs. Aluminum wire coated with black plastic under proper seizure list duly signed by the arrested accused person and witnesses.

I prepared label in r/o the said seized vehicle under the signature of the witnesses and the arrested accused person. I supplied copy of seizure list to the accused persons under their signature as mark of acknowledgement

Since the circumstances laid to hold my view and as per believable confessional statement of the arrested accused person disclosed an offence punishable u/s 379/411/413/414 IPC. I pray that a specific case accordingly may kindly be started against the arrested accused person, Chiranjit @ Jhony Sen S/o Astik Sen of Tantipara, Ward No 2, PS - Raghunathpur, Dist.- Purulia and others and to arrange its investigation.
