Sir,

In producing herewith one arrested accused person namely Ravi Kumar Sahu S/o Pradeep Sahu of Vill.+PO - Murgu, PS - Sasai, Dist.- Gumla, Jharkhand under arrest along with seized articles as per seizer list i.e. 15 (Fifteen) bottles Country Sprit measuring 600 ml each styled as 'Dilse' kept in a white colour plastic bag under proper seizure with label.

I SI Biswajit Sarkar of Raghunathpur PS hereby lodged a written complaint against the above noted accused person to the effect that on 10.06.2021 at about 06:35 hrs during my night mobile duty I received a credible source information that the above noted accused person was selling country sprit illegally at Rakshatpur more under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with C/185 Rajesh Kr Roy and C/238 Dipak Bagti both of Raghunathpur PS left to work out the information (This refers to Raghunathpur PS CC No. 1235/21 dated 09/06/2021). At 06:55 hrs we reached at Rakshatpur more and my source shown the person from a distance who was selling the liquors in lonely place. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of country sprit "Dilse" bottles were kept there in concealing condition. On searched 15 (Fifteen) bottles Country Sprit measuring 600 ml each styled as 'Dilse' kept in a white colour plastic bag were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers/pedestrian illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly signed by the accused person & witnesses in between 07:15 hrs to 07:25 hrs in which One bottle of "Dilse" was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 07:35 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Ravi Kumar Sahu S/o Pradeep Sahu of Vill.+PO - Murgu, PS - Sasai, Dist.- Gumla, Jharkhand u/s-46A (c) of the Bengal Excise Act 1909.
