Sir,

In producing herewith arrested accused persons (1) Bikash Mudi (48), S/O Parbat Mudi of Bhabanipur, P.S. -Santalalih, Dist- Purulia (2) Jiten Bauri (18), S/O Taru Bauri of Banberia, (3) Mahib Ansary (26), S/O Maharam Ansary of Bahara(Fatehpur) Sl. No. 2 and 3 of PS - Para, Dist. - Purulia, (4) Shashti Rajak (35), S/O Nakul Rajak of Rampur, Maharajganj, P.S - Purbi Pundi, Dist. - Dhanbad(Jharkhand). I, SI Sourav Kanti Das of Santalih PS do hereby lodge complaint that today (18.06.2021) at 13:25 hrs, when myself along with force were engaged in mobile duty at PS area and found the above noted persons were moving in front of STPS Township gate no. 1 under Santalih PS, without wearing Mask or any face guard, as such I detained them on that spot. On being asked the above noted persons could not give any satisfactory answer for not wearing Mask / face guard in this pandemic situation. As such the above noted persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide order no. 647-ISS/2M-22/2020, Dated 15.05.2021. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly, the above noted persons were arrested after maintaining all the formalities regarding arrest and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188 IPC & Read with section 51(1)(b) of The Disaster Management Act, 2005 may kindly be initiated against (1) Bikash Mudi (48), S/O Parbat Mudi of Bhabanipur, P.S. -Santalalih, Dist- Purulia (2) Jiten Bauri (18), S/O Taru Bauri of Banberia, (3) Mahib Ansary (26), S/O Maharam Ansary of Bahara(Fatehpur) Sl. No. 2 and 3 of PS - Para, Dist. - Purulia, (4) Shashti Rajak (35), S/O Nakul Rajak of Rampur, Maharajganj, P.S - Purbi Pundi, Dist. - Dhanbad(Jharkhand).
