Sub: Complaint against Sk Alim (24 years), S/O- Sk Dilu of Vill- Murulia, PS - Santuri, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Sk Alim (24 years), S/O- Sk Dilu of Vill- Murulia, PS - Santuri, Dist - Purulia along with following seized articles -

- 1) 14 Liters (Approx) of country spirit contained in a white coloured plastic container.
- 2) Out of seized country spirit One (01) liter taken out in a separate container as sample
- 3) One motorcycle bearing registration No -WB 38AB/0984

I beg to submit that today (10.06.2021) during my Special raid duty at about 19:25 hrs on acting a secret source information that one person is selling illegal country spirit for his personal gain. Accordingly I along with force rushed to the spot for holding raid by Govt. vehicle. At about 19:45 hrs I along with force reached at Atumajhirdih Village near Pump House under Santuri PS , Dist. -Purulia. After held raid and found that one Sk Alim (24 years), S/O- Sk Dilu is selling the country spirit at Atumajhirdih Village near Pump House under Santuri PS , Dist. - Purulia and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accused person Sk. Alim, and detained him. I arrested the above mentioned accused person informing the ground of arrest and seized above noted articles after preparing proper seizure list duly signed by the accused person and available witnesses and also sealed and labeled the same. Out of seized country spirit One (01) liter taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Sk Alim (24 years), S/O- Sk Dilu of Vill- Murulia, PS - Santuri, Dist - Purulia violate section 18 (i) B.E. Act. for possession and shelling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/1424 Bhairab Patra (2) C/863 Rupchand Pauria accompanied me Vide Santuri P.S.C.C No- 1789/2021, Dated 10.06.2021.

Under the fact and circumsances I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Sk Alim (24 years), S/O- Sk Dilu of Vill- Murulia, PS - Santuri, Dist - Purulia .
