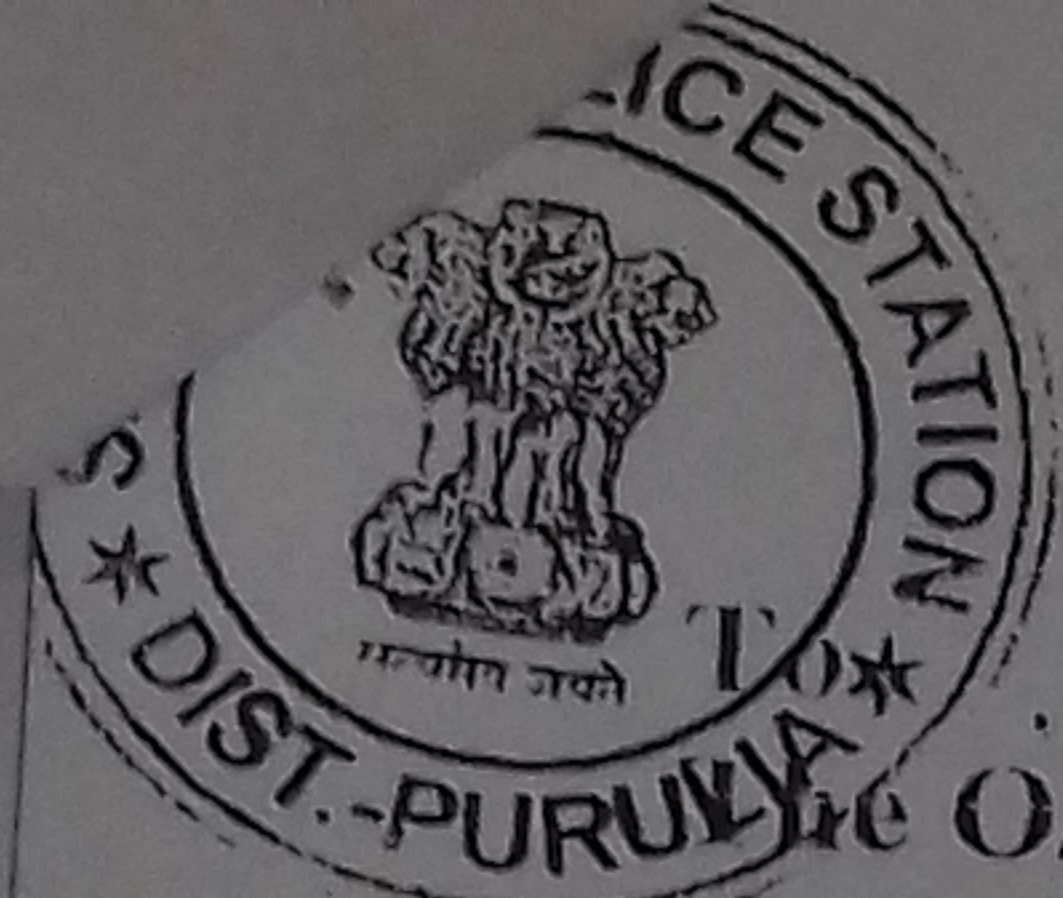




Sir,

I, SI Biswarup Roy, S/O- Lt. Jitendra Nath Roy of Bahadurpur P.S-Jamuria, Dist- Paschim Bardhaman now posted at Santuri PS, Dist- Purulia produce (1) Md Nagibulla Ansari (58yrs), S/O- Lt Ajmutullah Ansari, of Vill- Sunuri, PS-Santuri, Dist- Purulia (2) Bidyut Chatterjee (32yrs) S/O- Lt. Karali Chatterjee of do (3) Dilip Gorain (30yrs), S/O- Madhusudan Gorain of Vill- Kotaldih, Mallickpara, PS-Santuri, Dist- Purulia (4) Durgadas Dey (43yrs), S/O- Lt Sastipada Dey of Vill- Lalgarth, PS-Santuri, Dist- Purulia (5) Suman Banerjee (19 yrs), S/O- Naran Banerjee of Vill- Kinaidh, PS-Santuri, Dist- Purulia hereby lodge a written complaint against them, to the effect that today on 12/06/2021 while I along with C/702- Anal Kanti Banerjee & NVF/717 Haren Ch. Mahato of Santuri PS as per direction engaged in evening mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 470, dtd. 12/06/2021 vide C.C. No. 1813/21 dtd. 12/06/2021) for implementation of Government rules regarding Disaster Management Plan. On 12/06/2021, while we returning from Muradih side under Santuri P.S jurisdiction and reached at Muradih Station Bazar at about 17:25 hrs found that the above noted 05 (Five) persons were gossiping at Muradih Station Bazar without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 486-CS/2021 Dat 1-24<sup>th</sup> April 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Karali Chatterjee of do (3) Dilip Gorain (30yrs), S/O- Madhusudan Gorain of Vill- Kotaldih, Mallickpara, PS-Santuri, Dist- Purulia (4) Durgadas Dey (43yrs), S/O- Lt Sastipada Dey of Vill- Lalgarth, PS-Santuri, Dist- Purulia (5) Suman Banerjee (19 yrs), S/O- Naran Banerjee of Vill- Kinaidh, PS-Santuri, Dist- Purulia under proper sec. of law as they disobeyed/Ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
