

Sir,

I, SI Subrata Patra S/O- Shri Bimal Patra of Vill. Ishabpur, P.S Belda, Dist. Paschim Medinipur do hereby produce (1) Goutam Majhi (40 yrs), S/O- Ganesh Majhi, Vill- Madhubanpur, PS-Santuri, Dist. Purulia (2) Gunamoy Mal (45Yrs) S/O- Dhara Mal, Vill- Rambhattadih, PS-Santuri, Dist. Purulia, (3) Md. Abdul Sattar (40 yrs) S/O-Md Mustak, Vill- Matidundra, PS-Santuri, Dist. Purulia (4) Madhab Mandal (50 Yrs) S/O- Lt. Satish Ch. Mandal (5) Nandadulal Boral (36 Yrs) S/O- Prabodh Boral both of Vill+PS- Santuri, Dist. Purulia (6) Kokil Manna (45 Yrs) S/O- Sahadev Manna, Vill- Rangdih, PS-Neturia, Dist- Purulia A/P Vill.- Madhubanpur under Santuri PS , Dist.- Purulia do hereby lodge a written complaint against them, to the effect that today on 20/06/2021 while I along with C/330 Banamali Soren & C/702 Anal Kanti Banerjee of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 770 dtd. 20.06.2021 vide C.C. No. 1914/21 dtd. 20.06.2021) for implementation of Government rules regarding Disaster Management Plan. On 20.06.2021 while we returning from Sadhusaltora side under Santuri P.S jurisdiction and reached at Ledason Morh through Raghunathpur-Saltora Road at about 13:35 hrs. found that the above noted 06(Six) persons were gossiping near Ledason Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 753-ISS/2M-22/2020 Dated- 14/06/2021Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Goutam Majhi (40 yrs), S/O- Ganesh Majhi, Vill- Madhubanpur, PS-Santuri, Dist. Purulia (2) Gunamoy Mal (45Yrs) S/O- Dhara Mal, Vill- Rambhattadih, PS-Santuri, Dist. Purulia, (3) Md. Abdul Sattar (40 yrs) S/O-Md Mustak, Vill- Matidundra, PS-Santuri, Dist. Purulia (4) Madhab Mandal (50 Yrs) S/O- Lt. Satish Ch. Mandal (5) Nandadulal Boral (36 Yrs) S/O- Prabodh Boral both of Vill+PS- Santuri, Dist. Purulia (6) Kokil Manna (45 Yrs) S/O- Sahadev Manna, Vill- Rangdih, PS-Neturia, Dist- Purulia A/P Vill.- Madhubanpur under Santuri PS , Dist- Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
