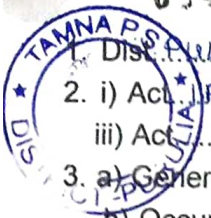

Sir,


With due respect, I beg to state that I ASI Pradip Kumar Supakar S/O Late Gouri Shankar Supakar presently posted at Tamna PS, Dist-Purulia, am lodging complaint as Suo-moto against above mentioned accused, I beg to report that on 04.06.2021 at early morning at about 05.50 hrs. when I was performing on duty table officer at Tamna PS at that time Accused Goutam Gorain, (who was arrested in c/w Tamna PS Case No- 46/2021 Dated 02.06.2021 u/s- 452/326/436/307/302/120B IPC on 03.06.2021 and had been put into PS Lock-up), he requested to for Nature's Call according he went to Latrine by sentry Junior constable-1426 Meraj Ansari of Tamna PS with a white color Gamchha like as Dhoti, of outside of Hazat after entering into Latrine he locked the door of latrine from inside. Within a while some growling sound was coming inside from said Latrine, instantly sentry Junior constable-1426 Meraj Ansari of Tamna PS called all colleague namely SI Bikash Chandta Patra, ASI Pradip Kumar Supakar, C/-391 Satya Sundar Kundu and NVF-940 Bhairab Mahato who were present nearby with Tamna PS premises, after that we together broke open the door of Latrine and had found that said Goutam Gorain knot the said white color Gamchha, in his neck and put the same into Iron Pipe existed within down asbestos roof of Latrine. Immediately he has been rescued and had been shifted to Purulia DM Govt. Medical College & Hospital where he has been presently admitted at Prisoner Ward.

Therefore, I pray that one specific case may kindly be started against arrested Accused Goutam Gorain (38 Yrs.) s/o Late Rathindranath Gorain of village Rampur, PS-Tamna , Dist-Purulia under Proper section of Law.
