So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.

Therefore, I pray a specific case may kindly be started against accused namely (1) Balaram Sahish (21 Yrs), S/O- Khagen Sahish of Vill- Chakda, P.O- Kotlui, PS- Tamna, Dist- Purulia, (2) Sibaprasad Mahato (44 Yrs), S/O- Lt. Rahin Mahato of Vill- Raghunathpur, P.O- Rupapeta, PS- Barabazar, Dist- Purulia, (3) Hiren Gorai (42 Yrs) S/O- Mahadev Gorai of Vill-+ P.O-Nipania, PS- Para, Dist- Purulia, (4) Sudip Mahato (19 Yrs), S/O- Abinash Mahato of Vill-+ P.O-Nipania, PS- Para, Dist- Purulia, (5) Rahul Ghosh (22 Yrs) S/O- Ujjwal Ghosh of Vill - Chakda, P.O- Kotlui, PS- Tamna, Dist- Purulia, (6) Sandip Kumar (24Yrs) S/O- Vudal Kumar of Vill- Kotlui, PS- Tamna, Dist- Purulia, (7) Subhankar Mandal (38 Yrs) S/O- Dhirendranath Mandal of Vill- Belguma, PS- Tamna, Dist- Purulia under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.
