So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.


Therefore, I pray a specific case may kindly be started against accused namely (1) Rampada Kora Mudi (25 Yrs), S/O- Subhas Kora Mudi of Vill- Dhadanga Nischintapur, PS- Barabazar, Dist- Purulia, (2) Karam Chand Mahato (30 Yrs), S/O- Premchand Mahato of Vill- Simulia, PS- Tamna, Dist- Purulia, (3) Asraf Ansary (30 Yrs) S/O- Sultan Ansary of Vill-Tamna, P.O-Chakaltore, PS- Tamna, Dist- Purulia, (4) Sreejit Banerjee (24 Yrs), S/O- Shyamaprasad Banerjee of Vill- Napitpara, PS- Purulia (T), Dist- Purulia, (5) Dactor Mahato (35 Yrs) S/O- Gunadhar Mahato of Vill - Ragma, PS- Barabazar, Dist- Purulia, (6) Aditya Mahato (20Yrs) S/O- Dibakar Mahato of Vill- Banabir, PS- Barabazar, Dist- Purulia, (7) Budheswar Mahato (27 Yrs) S/O- Tulsi Das Mahato of Vill- Kantasiari, PS- Tamna, Dist-Purulia, (8) Sanjit Kumar Mondal (35 Yrs) S/O- Mathuresh Mondal of Vill- Sirkabaid, PS- Arsha, Dist-Purulia under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.


