Sub: Request for lodging FIR against arrested accused person 1) Md. Khursid (24 Yrs) S/O Md. Sultan of Upper Benasol, PS-Adra, Dist- Purulia & 08 Others.

In production herewith 09 (Nine) arrested accused persons namely: 1) Md. Khursid (24 Yrs) S/O Md. Sultan of Upper Benasol, PS-Adra, Dist- Purulia. 2) Santas Kumar Yadav (26 Yrs) S/O Ramit Yadav of Upper Benasol Gowaly Para, PS- Adra, Dist- Purulia. 3) Binod Singh (30 Yrs) S/O Sukdeb Singh of Palankola, Goswami Para, PS- Adra, Dist- Purulia. 4) Krishna Ch Singh (58 Yrs) S/O L.L. Ganja Ch Singh of R/OH No-ESA, Upper Benasol near Police Para, PS- Adra Dist- Purulia. 5) Md. Rizwan Husain (35 Yrs) S/O Md. Jabir of Kamlaathan, PS- Adra Dist- Purulia. 6) Ramji Rajak (58 Yrs) S/O L. I beg to state that today (08.07.2021) I was directed to find out whether the guidelines of Govt regarding not wearing face mask in public in this pandemic situation has been implemented properly at Adra Bazar area or not. Accordingly, I had been to Adra Bazar near North Booking Counter along with force vide CC No-1817/21 dtd 08.07.2021 at about 21:45 hrs and found that a gathering assembled at North Booking Counter, Adra Bazar, none of them was wearing face mask. On seeing Police party they have tried to escape from the grip of police party but none failed to escape due to efficiency effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc. for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 79/G.S. 2020 dated 12.04.2020 of the Government of West Bengal, Wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715/Home (Cons) RIM/Cons/92/2021 dated- 17.04.21, followed by restriction order 753-II-1882M - 22/2020 Dated- 28.06.2021 of Government of West Bengal has stressed that any violation of mask and social distance norms should be strictly dealt with.

I arrested them for disobedience to order duly promulgated by public servant after maintaining all rules of arrest, issued memo of arrest & Inspection Memo. I informed them & their relative regarding the ground of arrest i.e. provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. All the process was done at 21:55 hrs to 23:05 hrs. All of them violated the Govt. Order regarding restriction of movement from 21:00 hrs to next day 05:00 hrs.

Therefore, I pray a specific case may kindly be lodge against 1) Md. Khursid (24 Yrs) S/O Md. Sultan of Upper Benasol, PS-Adra, Dist- Purulia & 08 others as above noted need. Persons they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life U.S. 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 and arrange for investigation.
