Sir,

In producing herewith one arrested person namely Nirmal Kumar Hansda (31 yrs) S/O Sohilal Hansda of Vill- Paharpur, PS - Kashipur, Dist- Purulia along with seized vehicle (Tractor) bearing WB 81 1864 and Chassis No-HZQSG748867SM, engine number not traced along with sand loaded Trolley without number plate seized under proper seizure list and memo of arrest in respect of the supra person before you.

The nub of the fact in a nutshell is that today 09.07.2021 at 17.05 hrs while I along with force namely 1) C/122 Rabindra Kumar Verma 2) C/201 Rabindranath Nag left the PS for performing evening petrol duty vide MCC No 1827/21 Dated 09.07.2021 and Adra PS GDE no 387 Dated 09.07.2021 in PS area. During my petrol duty, I received a tip off at 17:35 hrs that a suspicious tractor loaded with sand was coming from Sarberia village side towards Barabagan, Adra, Purulia. Subsequently, I along with force proceeded towards Sarberia village to work out the tip off. While I along with force arrived near Sarberia village, I asked local people who gathered at that place to become witnesses but none came forward and all of them left the place. After that I found that one tractor was coming from Gourangdih village side under Kashipur PS. I along with force intercepted the vehicle (Tractor) bearing WB 81 1864 attached with Trolley loaded with sand after placing the guardrail on the road at 17:45 hrs at Sarberia village and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Darkeswar River at Paharpur Ghat side by fraudulently means or theft by any means for transporting the same to run clandestine business. During interrogation the driver clearly confessed that he habitually deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia Memo No - VI/430 (Part - VIII)/1176/M/90/M/17 Dtd.26.06.2020, regarding ban of sand lifting from Riverbed. So I, seized the tractor bearing WB 81 1864 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Nirmal Kumar Hansda (31 yrs) S/O Sohilal Hansda of Vill- Paharpur, PS - Kashipur, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said tractor to Adra P.S.

Under the above facts and circumstances kindly take lawful action against the driver namely, Nirmal Kumar Hansda (31 yrs) S/O Sohilal Hansda of Vill- Paharpur, PS - Kashipur, Dist- Purulia and the owner of the vehicle vide Reg. No- WB 81 1864 as they committed offence U/S 188/379/411/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act- 1957.
