In producing herewith arrested accused person namely Amardip Kuiry (30 Yrs) S/O Dipak Kuiry of Vill-Palashkola, near Upakar club, PS-Adra, Dist- Purulia along with seized articles (1) One Motor cycle bearing Reg. No-WB 82/6623 (2) One driving license in the name of Amardip Kuiry vide D/L No-WB 8120180007998 along with all connected papers.

I beg to report that today myself along with C/2499 Rintu Mondal and C /3160 Ranjit Nayek both of Adra PS were performing special NAKA checking duty at Adra Bus Stand under Adra PS area vide Adra PS Misc C.C No-1963/21 dtd.24.07.2021 and Adra PS GDE No-1008. At about 18:25 hrs, I found one motor Cycle bearing Reg. No-WB 82/6623 coming from Adra rail gate side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC at about 18:35 hrs. I also seized the motor cycle and his driving license with a view to prosecute him U/S 279 IPC in presence of witnesses. The whole process of seizure was completed in between 18:35 hrs to 18:45 hrs. His family member was also informed about the ground of arrest.

Afterwards he was released on bail after issuing Bail bond & PR bond.

Hence I pray that a specific case U/S 279 IPC may kindly be initiated against accused Amardip Kuiry (30 Yrs) S/O Dipak Kuiry of Vill- Palashkola, near Upakar club, PS-Adra, Dist- Purulia.
