**Sir,**

In producing here with one arrested accused namely Tarapada Baskey (42 Yrs) S/O Lt. Bodi Baskey of Vill- Kantaranguni, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 15 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-50 of each bottle.

I ASI Tanmoy Chatterjee of Adra PS do here by lodged a complaint against accused namely Tarapada Baskey (42 Yrs) S/O Lt. Bodi Baskey of Vill-Kantaranguni, PS-Adra, Dist- Purulia to the effect that on 03/07/21 at about 19:05 hrs I received information from a reliable source that one Tarapada Baskey has been stock of country spirit illegally at his House/Shop at Kantaranguni. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS GDE No-106 dtd.03.07.21. I reached at Kantaranguni Adra at about 19:35 hrs and hold raid in the House/Shop of said Tarapada Baskey and found that the said person selling liquor at his house and after seeing the Police party some person fled away and said Tarapada Baskey has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid license or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Tarapada Baskey selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.35 hrs to 20.05 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Tarapada Baskey (42 Yrs) S/O Lt. Bodi Baskey of Vill-Kantaranguni, PS-Adra, Dist- Purulia under proper section of law.
