Sir, Respectfully I draw your kind attention towards the incident occurred in my house on 06.07.21 at about 11:30 AM today (DVC/colony, Kanda Rangum, Atra

1) my daughter in law Afsha Pragam A.P. Late Iqbal Hussain of Bankura against who I have lodge an F.I.R. on 3/7/21 at Atra for attacking my house & Lang with gang of ladies and gents of Bankura led by her uncle Mr. Nazimuddin nic name Bablu on 3.7.21 at noon. again created large scale violence today on 6.07.21 as under.

1) At about 12:30 PM I was Praying she began shouting and quarreling suddenly. I was rushed to the kitchen room by breaking the Namaj to control the situation. She pushed me badly and throws dirt water on me by the long brush cleaning the floor.

2) Servant phone of my son <sup>Shasid Nawar</sup> was smashed and broken, tore her cloth and throw the table and chairs even became rashed in side. Ladies of the locality came & and Pelted her cloth.

3) As guardian of my house I have tryed my level best to control the situation but failed even child was thrown and on the bed and assaulted me. I am aged person having problem of Diabetes and Blood pressure, my wife is also chronic Patient also my elder son is Mentored Patient.

4) I have intimated I/c over phone twice.

5) Ladies of locality & Social activities is called she didnot listen to them.

6) By the time Police arrived and tryed to control her aggressive nature. She also refused their advice.

even ladies police requested they  
to come to PS but she refused and  
left in the ground outside home  
showing she was again with child  
brought to home.

In this connection it may be  
mentioned here that such a violent  
incident was done in the past also  
as told by myself.

- 1) On 26.8.18 she created violent act  
in my house, people of the locality  
and social ~~state~~ activists, mahilasangam  
members and her guardian from Bankura  
arrived and stop her violent act  
she has given in writing not to do  
such a thing in future (Verax copy  
also enclosed)
- 2) Again after three/four days she created  
violence at my home. Her mother &  
brother was intimidated. They came and  
take her to Bankura. She was given  
one taluk through notary Raghunathpur (waming  
(Taluk) to which was taken back through  
+ on submission of her apology through  
official notary Bankura (Verax copie enclosed)

We are now much scared  
about her aggressive nature and  
it has now reached boiling point

Please take m. a. against her  
to avoid loss of life
