In producing here with one arrested accused namely Tilok Singh (32 Yrs) S/O Kishto Singh of Vill- Lower Beniasol near SBI Adra, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 40 bottles DIL KHUSH country spirit, 300 Ml. each Rs/-25 of each bottle.

I SI Sourav Banerjee of Adra PS do here by lodged a complaint against accused namely Tilok Singh (32 Yrs) S/O Kishto Singh of Vill- Lower Beniasol near SBI Adra, PS-Adra, Dist- Purulia to the effect that on 30/07/21 at about 18:15 hrs I received a information from a reliable source that one Tilok Singh has been stock of country spirit illegally at his Shop near Bilmoriya More during my special mobile duty vide CC No-3035/21 dtd.30.07.21. After getting such information I along with my accompanied force left for Bilmoriya More to work out the Information. I reached at Bilmoriya More, Adra at about 18:45 hrs and hold raid in the Shop of said Tilok Singh and found that the said person selling liquor at his house and after seeing the Police party some person fled away and said Tilok Singh has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Tilok Singh selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.05 hrs to 19.45 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Tilok Singh (32 Yrs) S/O Kishto Singh of Vill- Lower Beniasol near SBI Adra, PS-Adra, Dist- Purulia under proper section of law.
