Sir,

I am producing herewith following arrested accused persons for the fact that, today (17.07.2021) during my Special mobile duty (Arsha PS GDE No. 575 dtd 17.07.2021) with (i) C/ 28 Dipak Dolui (ii) C/252 Anil Tamang and (iii) C/517 Bagha Singh Sardar all of SAP 7th BN Camp at Arsha PS vide Arsha PS CC No. 1436/21 dtd 17.07.2021 had been at Aharra More and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during this Covid-19 pandemic situation. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 21.25 hrs to 22.05 hrs and brought to PS (vide Order No. 753/III-ISS/2M-22/2020 Dtd. 14.07.2021).
