In producing herewith 1. Tulshi Charan Mahato (45 Yrs), S/O-Lt-Harmohan Mahato, 2. Dasarath Mahato (61 Yrs), S/O-Lt-Laxman Mahato both of Vill-Dhanudih, 3. Rajesh Khan (48 Yrs), S/O-Laxmi Narayan Khan of Vill-Matha, 4. Hemanta Kumar (32 Yrs), S/O-Ghanashayam Kumar of Vill-Maunia, 5. Sasti Sing Sardar (18 Yrs), S/O-Sahadev Sing Sardar, 6. Prakash Sing Sardar (18 Yrs), S/O-Arup Sing Sardar both of Vill-Digardih, 7. Harihar Mahato (35 Yrs), S/O-Malin Mahato of Vill-Anandanagar, 8. Jagjiban Sing Mura (45 Yrs), S/O-Budhu Sing Mura of Vill-Bidyajara all are of PS-Baghmundi, Dist- Purulia to the effect that on 25.07.2021 while I SI Sudhir Kumar Mahato along with force 1) C/175 Prasenjit Ghosh and 2) C/613 Buddheswar Sing both of SAP 11th Bn. camp at Baghmundi PS, Dist-Purulia were performing evening mobile duty vide Baghmundi PS GDE No- 1168, Dated- 25.07.2021 & C.C. No- 2200/21, dtd- 25.07.2021. During my special mobile duty when myself along with force reached at Charida More on Baghmundi-Jhalda Main Road in between 18:15 hrs to 19:45 hrs and found above persons were roaming aimlessly at Charida More Area without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No-486-CS/2021, Dtd: 24.04.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request. So I arrested them for violating the section of Disaster Management Act 2005 after maintaining all arrest related guidelines and rules.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
