Bijoy Mahato (28 Yrs), S/O- Yudhistir Mahato of Vill- Kudna, 7. Bharat Chandra Mahato (37 Yrs), S/O- Srihari Mahato of Vill- Koreng, 8. Banikanta Mura (33 Yrs), S/O- Laxminarayn Mura of Vill- Hikimdih and all are of PS- Baghmundi Dist-Purulia to the effect that on 17.07.2021 while I SI Bangshi Badan Mandal along with force 1) C/435 Kinkar Ch. Majhi and 2) C/577 Biswajit Poddar both of SAP 11th Bn. camp at Baghmundi PS, Dist-Purulia were performing evening mobile duty vide Baghmundi PS GDE No- 743, Dated- 17.07.2021 & C.C. No- 2128/21, dtd- 17.07.2021. During my mobile duty when myself along with force reached at Ajodhya More on Baghmundi-Balarampur Main Road at 17:55 hrs and found above persons were roaming aimlessly at Ajodhya More Area without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No-486-CS/2021, Dtd: 24.04.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request. So I arrested them for violating the section of Disaster Management Act 2005.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
