On 26/07/2021 at about 11:10 a.m. Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Subhasis Mahato, Sr. OE, 2. Sri Sajal Kumar Mahanty, Sr. OE 3. \_\_\_\_\_ entered the premises of Sri Asutosh Kumar, S/O- Lt. Motilal Kumar of village Chhatatar, P.O- Bagmundi, Dist- Purulia and found Sri Asutosh Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.3 KVA. As Sri Asutosh Kumar S/O- Lt. Motilal Kumar committed theft of electric power, So, I seized the following articles after preparing the seizure list in presence of 1. Sri Subhasis Mahato, Sr. OE, Bagmundi CCC 2. Sri Sajal Kumar Mahanty, Sr. OE The inspection team left the premises at 11:20 a.m.
