On 26/07/2021 at about 11:35 a.m. Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Subhasis Mahato, Sr.OE 2. Sri Sajal Kumar Mahanty, Sr.OE 3. _____ entered the premises of Sri Tapan Kumar, S/O- Bhusan Kumar of village Chhatar, P.O- Bagmundi, Dist- Purulia and found Sri Tapan Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.3 KVA. As Sri Tapan Kumar S/O- Sri Bhusan Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Subhasis Mahato, Sr.OE, WBSEDCL 2. Sri Sajal Kumar Mahanty, Sr.OE, WBSEDCL the inspection team left the premises at 11:45 a.m.
