In producing herewith 1. Bikram Sing Babu (35 Yrs), S/O-Lt-Rintu Sing Babu, 2. Sanat Sing Mura (25 Yrs), S/O-Lt-Bondol Sing Mura, 3. Biswanath Khanna (51 Yrs), S/O-Lt-Gobindanath Khanna, 4. Barun Sing Mura (40 Yrs), S/O-Lt-Janak Sing Mura, 5. Krishna Sing Babu (23 Yrs), S/O-Lt-Baju Sing Babu, 6. Kinkar Mahato (40 Yrs), S/O-Sudhir Mahato all of Vill-Burda, 7. Basdeb Mahato (28 Yrs), S/O-Lakhipada Mahato, 8. Chhutulal Hansda (27 Yrs), S/O-Kartick Hansda both of Vill-Munibera all are of PS-Baghmundi, Dist- Purulia to the effect that on 29.07.2021 while I PSI Snehasish Mondal along with force 1) C/175 Prsenjit Ghosh 2) C/577 Biswajit Poddar both of SAP 11th Bn. camp at Baghmundi PS, Dist-Purulia were performing evening mobile duty vide Baghmundi PS GDE No- 1397, Dated- 29.07.2021 & C.C. No- 2244/21, dtd- 29.07.2021. During my special mobile duty when myself along with force reached at Koreng More on Baghmundi-Jhalda Main Road in between 19:05 hrs to 19:45 hrs and found above persons were roaming aimlessly at Koreng More Area without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No-486-CS/2021, Dtd: 24.04.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request. So I arrested them for violating the section of Disaster Management Act 2005 after maintaining all arrest related guidelines and rules.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
