00010) Chaitan Singh Paradar of Vill. Bhaurvalish, P.S. Balasamput, Dist. Paralia. 3 Dinesh Mishra
(D 00010) N.S. Bhagat Mahant of Vill. Bhaurvalish, P.S. Balasamput, P.S. Paralia. 1 Suresh Singh (P
00010) Gangaiah Majhi of Vill. Khatola, P.S. Balasamput, Dist. Paralia. (original Paradar (P
00010) Ganpat Sotthalia of Vill. Chouda, P.S. Balasamput, Dist. Paralia were moving
assembly. Despite of having the importance of wearing mask, some of them put it on. Rather they
started giving excuses for not wearing the same and tried to give themselves Police party. It was
noticed recently that rapid awareness programmes through community had been done since last
month by the Balasamput Police Station but these people did not take care of that. Hence, from
every means to believe that the assembly persons came and from there to our district one content
which may result in spreading of infection. As such the above persons violated the order during
his pandemic situation duly promulgated by Govt. of India (legal vide order No. 02/04/20-
21) dated 03.05.2020 (Order No. 54/0001) (04/24) 2020 dated 1st June 2020 and subsequently
P.N.2) 2020 dated 12/09/2020, P.S. Home (Case) 0001/0001/2020 dated 17/12/2020 and also
vide No. 001/2020-0001/04) dated 29/09/2020. Therefore they disobeyed court order and
criminal negligent act likely to spread infection of disease dangerous to life. Hence I arrested
them after maintaining all arrest formalities regarding arrest printed by MHA and Apex Court of
India.

Under the above circumstances, I pray that a cognizable case may kindly be started against
above noted 09 (nine) persons.
