On 19/07/2021 myself and Subinsia Nathi Muralid along with some were engaged in mobile duty vide C.C No. 2001/2021, C.M No. 1101/2021/2021 and as per direction we were engaged for implementation of C.O. order regarding restriction of movement of mass. At about 21:15 hrs, myself along with force already been stop a Nika-Chucking post at Bolanampet Dist. road. During Nika checking we found that the 84/90 persons moving aimlessly without wear mask & wear the Police party they are that many somewhere are managed by group persons namely: 1) Ash Reddy (D no) 540- Parvathi Ch. Tando of Vill- Bannath, P.S- Bolanampet, Dist-Parvathi, 2) Sanku Parvathi (D no) of Vill- Chidlagana, P.S- Bolanampet, Dist-Parvathi were moving aimlessly. Despite of having the importance of wearing mask none of them put it on. Rather they started giving excuses for not wearing the same and tried to pass through our Police party. It is to mention hereby that rapid awareness programmes through community had been done since last month by the Bolanampet Police Station that these people did not take care of that. Hence, there is every reason to believe that the above said person came out from their home without any reason which may result in spreading of infection. In such the above persons violated the order during this pandemic situation duly promulgated by Govt. of Andhra Pradesh vide up dated order No. 707/WR-PR/2020/2021 dated-14/07/2021 and subsequently Order No- 829/PR/2021/21/2021 dated-05/08/2021, Order No- 547/2006/2018-24/2021 dated 3rd June 2021 and Order No- 3943/2021 dated 12/06/2021, 10th Home (1000) 001 (1000) 05/2021 dated 07/06/2021 and also order No- 407/2006/2021/2021 dated-29/04/2021. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of disease dangerous to life. Hence I arrested them after maintaining all usual formalities regarding arrest guided by M.B.C and Apex Court of India.

Under the above circumstances, I pray that a cognizable case may kindly be started against above noted 82 persons.
