In producing herewith 02 (two) arrested accused persons namely (1) Snehashish Dutta (28Y) S/O-Subhash Chandra Dutta (2) Panchanan Kalindi (32Y) S/O-Nilkamal Kalindi both of Vill-Patamda (Block Colony), PS-Patamda, Dist-East Singbhum, Jharkhand along with one seized vehicle (Maruti Omni) bearing Reg No-JH-05CG/3859. I beg to state that today i.e. on 01/07/2021, I SI Jol Kumar Mandy of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-47, Date-01.07.21 & MCC No-1585/21, Date-01.07.2021 find out whether wearing of mask by the public has been properly maintained at Bandwan Bazar area or not and also to observed Lock down protocol at night from 09.00 PM to 05.00 AM. Accordingly, I had been to Bandwan Chwak Bazar area at about 21:55 hrs and found that the above noted persons with his vehicle (Maruti Omni) bearing Reg No-JH-05CG/3859 was coming to Bandwan Chwak Bazar without any face cover mask. Police party detained him at Bandwan Chawak Bazar and found both of fully drunken condition. On being asked he could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. On enquire it revealed that the person is the inhabitant of Jharkhand state and without any valid reason he was moving at Bandwan Bazar with drunken condition.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government through public servants and through media by strolling, riding without mask instead of following the COVID rules of wearing mask and not to stroll after 09.00 PM as there is complete lockdown after 09.00 PM to 05.00 AM. They are creating annoyance in that locality & violated Govt. order No. 753-ISS/2M-22/2020, Dtd-14/06/21 & Govt. order No. 753/II-ISS/2M-22/2020, Dtd-28/06/21 for complete restriction measure. So, I arrested them for Disobedience of order duly promulgated by public servant after maintaining all rules of arrest, issued memo of arrest & seized the said vehicle (Maruti Omni) bearing Reg No-JH-05CG/3859. I informed them and their family members over mobile phone regarding the ground of arrest. At prima facie there were sufficient evidences to secure their detention. All the process was done in between 22:05 hrs to 22:45 hrs.

Therefore, I pray a specific case may kindly be lodge against (1) Snehashish Dutta (28Y) S/O-Subhash Chandra Dutta (2) Panchanan Kalindi (32Y) S/O-Nilkamal Kalindi both of Vill-Patamda (Block Colony), PS-Patamda, Dist-East Singbhum, Jharkhand as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated the rule.
