Sub: Complaint against (i) Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimai Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill- Barabazar Uparpara, both of PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with 02 arrested accused persons namely (i) Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimai Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill-Barabazar Uparpara, both of PS- Barabazar, Dist- Purulia and seized articles (i) One white colour Jerkin containing approx 20 Liters I.D Liquors (ii) One white colour Jerkin containing approx 20 Liters I.D Liquors (iii) One white colour Jerkin containing approx 15 Liters I.D Liquors (iv) 30 Pcs Plastic Glass (v) Empty pouch 40 pcs (vi) Water bottle 05 pcs (2 empty & 3 full) (vii) One Black colour plastic sheet (viii) Rs-255/- (Two Hundred Fifty Five), on which 01 liter seized as sample from each Jerkin as per enclosed seizure list.

I, ASI Manas Kumar Pan of Barabazar PS do here by lodge this complaint against (i) Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimal Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill- Barabazar Uparpara, both of PS- Barabazar, Dist- Purulia. On 10.07.2021 at about 20.45 hrs during my special mobile duty received a source information that some persons unauthorizly selling I.D liquors beside the pitch road on Barabazar - Berada, near Tentul Tree dark place near Barabazar Jaltanki morh under Barabazar PS, Dist- Purulia. I have been there to verify the credibility of that Information and immediately informed to I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to said place to work out the information. At about 21.05 hrs found 02 persons were selling I.D liquors on that place. When we reached the spot, seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that 02 persons kept 03 plastic Jerkin loaded with I.D liquors for selling. On demand, they failed to produce any valid documents / License in respect of selling and keeping of I.D liquors. On being asked they confessed their guilt and stated that they selling the ID liquors with intent to sell to make their own profit. They disclosed their identity as (i) Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimai Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill- Barabazar Uparpara, both of PS- Barabazar, Dist- Purulia. They also admitted that they have no license or any authorization for keeping and selling of I.D liquors. Accordingly, I seized (i) Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimai Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill- Barabazar Uparpara, both of PS- Barabazar, Dist-Purulia and seized articles (i) One white colour Jerkin containing approx 20 Liters I.D Liquors (ii) One white colour Jerkin containing approx 20 Liters I.D Liquors (iii) One white colour Jerkin containing approx 15 Liters I.D Liquors (iv) 30 Pcs Plastic Glass (v) Empty pouch 40 pcs (vi) Water bottle 05 pcs (2 empty & 3 full) (vii) One Black colour plastic sheet (vill) Rs- 255/- (Two Hundred Fifty Five) after preparing proper seizure list and put label on the seized articles in presence of witnesses and 01 liter of I.D liquor taken as sample from each Jerkin which were also duly labeled by me and also took signature of the accompanying witness on seizer list and label as well as accused persons also. Thereafter, I secured arrest the accused persons namely (i) Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimai Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill- Barabazar Uparpara, both of PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line. Informed them and their relatives regarding the ground of arrest. The arrest was made at 22.05 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against the arrested accused persons namely Satinath Dey (33 Yrs) S/o- Arun Kr. Dey of Barabazar Telipara (ii) Nimai Kundu Modak (50 Yrs) S/o- Lt. Mahabir Kundu Modak of Vill- Barabazar Uparpara, both of PS- Barabazar, Dist- Purulla under proper section of Law.
