Sir,

In producing here with arrested accused person namely Sukdeb Sahis (22 Yrs) S/o-Shraban Sahis of Vill+PO- Bankuchia, PS- Kamalpur, Dist- East Singhbhum, Jharkhand and selzed two bags loaded with 02 rubber tube approx 21 (Twenty One) liters I.D liquors on which 500 ml seized as sample from each tube as per enclosed seizure list.

I, ASI Sadhan Chandra Danda of Barabazar PS do here by lodge this complaint against Sukdeb Sahis (22 Yrs) S/o- Shraban Sahis of Vill+PO- Bankuchia, PS- Kamalpur, Dist- East Singhbhum, Jharkhand. On 29.07.2021 at about 23.35 hrs during my evening mobile duty I received information that one person was carrying I.D liquor and going towards Bhagabandh village. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. On 30.06.2021 at about 00.05 hrs I detained one person at Bhagabandh village morh under Latpoda G.P who was carrying 02 bags. Seeing the Police party the alleged person tried to flee away, but I apprehended him with the help of the Police party and on being searched I found that the person carrying two bags loaded with 02 rubber tube approx 21 (Twenty One) liters I.D liquors. On demand, he failed to produce any valid documents / License in respect of carrying I.D liquors. On being asked he confessed his guilt and stated that he carried the ID liquors with intent to sell to make his own profit. He disclosed his identity as Sukdeb Sahis (22 Yrs) S/o- Shraban Sahis of Vill+PO- Bankuchia, PS- Kamalpur, Dist- East Singhbhum, Jharkhand. He also admitted that he has no license or any authorization for carrying of I.D. liquors. Accordingly, I seized two bags loaded with 02 rubber tube approx 21 (Twenty One) liters I.D liquors after preparing proper seizure list and put label on the seized articles in presence of witnesses and 500 ml of I.D liquor taken as sample from each tube which were also duly labeled by me and also took signature of the accompanying witness on seizer list and label as well as accused person also. The seizure and label was done in between 00.15 hrs and 00.35 hrs. Thereafter, I secured arrest the accused person namely Sukdeb Sahis (22 Yrs) S/o- Shraban Sahis of Vill+PO- Bankuchia, PS- Kamalpur, Dist- East Singhbhum, Jharkhand after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line.
