With due respect and humble submission I beg to state that Today (i.e.17/07/2021) at about 21.55 hrs received a type complaint from PSI Malay Mishra of Boro P.S. Dist- Purulia. During his mobile duty he detained Nikhil Mandi (30) S/o- Lt Saktishwar Mandi of Vill- Kaludih, PO Kumra PS – Bandwan, Dist.- Purulia and 03 (Three) others were moving at Boro Kalitala more, PS-Boro, Dist- Purulia without wearing Mask (.) On being asked the involved persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation (.) As such the involved persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 (.) Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society (.) Accordingly, they have been arrested and released on bail from PS (.) Over this started Boro PS Case No 29/2021 dtd- 17.07.2021 U/S- 188/34 IPC and 51(b) Disaster Management Act, 2005. As per endorsement ASI Joydip Singha of Boro PS took up its investigation.



(4) Dhiren Gorai (27) S/O- Manik Gorai Vill- Baro Karmo PS-Bandwan Dist.- Purulia, stood surety for obtaining Bail and as per order released them on bail after taking proper bail bond & PR bond.
