On being asked the following persons could not able to give any satisfactory answer for not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm, or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society.
