

- 2) That the accused person bore grudge having animosity against the complainant since long and the accused persons under the opportunity to teach me a good lesson to the complainant.
- corresponding to 10th Baisakh 1428 B.S. at about 11:00 am the said Santosh Mahato i.e. the accused person all on a sudden without any provocation criminally trespassed in to the house of the complainant and started to abuse him and his family members in filthy languages. When the complainant protested then the accused person assaulted the complainant with the help of lathi causing minor injury on his person. The accused person also damaged some house



hold articles of the complainant causing loss of Rs. 12,000/-approximately. The accused person also cut and taken away two Sonaijhuri trees value of those threes would be Rs. 22,000/- approximately.

- 4) When the complainant raised protest the again assaulted the complainant with fist and blows by felling him on the ground, then the complainant raised hue and cry to save his life and property and when the neighboring people collected there then the above noted accused person fled away.
