In producing herewith the arrested accd. persons namely 1. Dayamoy Mondal(48) S/O- Samar Mondal 2. Kartik Acharjee (55) S/O- Bamapada Acharjee both of Vill- Salaya, PS- Kashipur, Dist- Purulia 3. Anil Bouri (36) S/O- Ananda Bouri of Vill- Upardih, 4. Ujjal Bouri(21) S/O- Muktaram Bouri of Vill- Chinabari, 5. Manoj Bouri (30) S/O- Bhaktipada Bouri of Vill- Chinabari, 6. Pradip Mahato (23) S/O- Sunil Mahato of Vill- Maheshana 7. Rabi Mahato (21) S/O- Dilip Mahato of Vill- Maheshana all of PS- Chhatna, Dist- Bankura.

Today (19.07.2021) I PSI Sk. Amanur along with C/1335 Nirmal kr. Mahato and C/959 Babu Ansary and NVF/908 Lakhindar Sing mura were performing mobile duty vide Hura PS GDE No-772 Dated-19.07.2021 and CC No 1953/21 dtd. 19.07.2021 and as per direction we were engaged for implementation of Govt. rules regarding Use of face mask and disaster management plan. At about 18.15 hrs, when myself along with force reached at Nimtola Morh on NH60A (Bankura - Purulia pitch road) area under Hura P.S. we found 07 (seven) persons namely 1. Dayamoy Mondal S/O- Samar Mondal 2. Kartik Acharjee S/O- Bamapada Acharjee both of Vill- Salaya, PS- Kashipur, Dist- Purulia 3. Anil Bouri S/O- Ananda Bouri of Vill- Upardih, 4. Ujjal Bouri S/O- Muktaram Bouri of Vill- Chinabari, 5. Manoj Bouri S/O- Bhaktipada Bouri of Vill- Chinabari, 6. Pradip Mahato S/O- Sunil Mahato of Vill- Maheshana 7. Rabi Mahato S/O- Dilip Mahato of Vill- Maheshana all of PS- Chhatna, Dist- Bankura were moving aimlessly having without mask. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives we arrested the above noted 07 (seven) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 07 (seven) persons came out from their home without having mask and moving aimlessly without any valid reason for making fun. In view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 and 17.04.2021 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 and 283-CS/2020 dated 21.07.2020 and 486-CS/2021 dated 24.04.2021 and Order No- 753/III-ISS/2M-22/2020, Dated- 14.07.2021. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S- 188/34 IPC & Read with section 51(i)(b) of National Disaster Management Act, 2005 may kindly be started against 07 (seven) arrested persons namely 1. Dayamoy Mondal S/O- Samar Mondal 2. Kartik Acharjee S/O- Bamapada Acharjee both of Vill- Salaya, PS- Kashipur, Dist- Purulia 3. Anil Bouri S/O- Ananda Bouri of Vill- Upardih, 4. Ujjal Bouri S/O- Muktaram Bouri of Vill- Chinabari, 5. Manoj Bouri S/O- Bhaktipada Bouri of Vill- Chinabari, 6. Pradip Mahato S/O- Sunil Mahato of Vill- Maheshana 7. Rabi Mahato S/O- Dilip Mahato of Vill- Maheshana all of PS- Chhatna, Dist- Bankura and arrange for its investigation.
