In producing here with one Tractor attached with Trolley loaded with sand without any number plate, having Engine No. RLJ2EMNI795 and Chassis No MBNABAEXKIJJ03526 before you.

The fact of the case in brief is that today (12/07/2021) I SI Prasanta Sau, C/386 Sibendhu Sinha, NVF/778 Samir Kr. Mahato and HG/1772 Fatik Ch. Kumar of Jhalda PS were performing evening mobile duty vide Jhalda PS GDE No- 527 Dated-12/07/2021 and in consonance with Jhalda PS CC No. 1884 dated 12/07/2021.on Purulia Ranchi Road. During my mobile duty, as per order of my superior, I started Naka at Birsha more for the implantation of the Govt. order for the night lock down. During my Naka checking at about 21:15 hrs I found one tractor attached with trolley was coming from Tulin side. Subsequently, I along with force signaled the said tractor to stop as the driver of the said tractor was not wearing mask and to check the movement of the tractor. On seeing my signal driver of the said tractor immediately stopped the vehicle yonder to my barricade and jumped from the said tractor and fled away and disappeared in the dark. Consequently, I along with force ran after him to nab but it was in vain. We tried our label best to search him in all adjacent probable places but failed. Searched the trolley of the tractor and found the trolley was loaded with approx 100 cft sand. I waited there for a reasonable period for the driver or the owner of the tractor, but none turned up before us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that the driver in cahoots with the owner of the vehicle procured the said sand from Subarnarekha River at Tulin side by fraudulently means or theft by any means for transporting the same to run clandestine business. Finding no other alternative I seized the said Tractors attached with Trolley loaded with approx 100 cft sand without any number plate, having Engine No- RLJ2EMNI795 and Chassis No-MBNABAEXKIJJ03526 after preparing proper seizure list at the spot in presence of the police witness due to night lock down no other public witness was available at that place.

It is pertinent to say that the driver and owner of supra noted tractor violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21. Ergo a specific case may kindly be initiated against them U/S-379/411/120B/188 of the IPC and 21 (1) (4) Mines and Minerals (R&D) Act-1957 and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act. 1897 and arranged for its investigation.
