The fact of the case in a nut shell is that I SI Sujit Das along with force namely (i) C/682-Mahadeb Rajak (ii) C/571-Md. Hasib Khan (iii) HG/1772-Fatik Ch, Kumar (iv) HG/1681-Marxnotha Kumar was performing the night mobile patrolling duty for the implementation of the Govt Order in the area vide Jhalda PS GDE No 753 dtd.17.07.2021 in consonance with C.C No 1938/21 Dtd. 17.07.2021 as per order of superior. During night patrolling duty, while he arrived at Mosinamore along Purulia Ranchi Road at 00:10 hrs. and started Naka and found 16 (Sixteen) persons noted in the supra (Sl no 1-16) were loitering aimlessly without wearing the mask and maintaining the social distance during the Night lock down in all over the state. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted loitering after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21. Ergo, they can be booked U/S 188 of the IPC and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act. 1897. Ergo a specific case may kindly be initiated against them and arranged for its investigation.
