On being asked they could not give sufficient reason or satisfactory answer of their unwarranted loitering after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020dtd. 14.07.21. Ergo, they can be booked U/S 188 of the IPC and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act. 1897. Ergo a specific case may kindly be initiated against them and arranged for its investigation.
