
In producing here with arrested accused persons namely 1) Chinmoy Tiwary (23 yrs) S/O Binod Tiwary of Vill- Dungal PO- Jhalda PS- Kotahila, Dist-Purulia, 2) Arjun Gorain (22 yrs) S/O Prabir Gorain of Pat Jhalda Road, Ward No 3, PS-Jhalda, Dist-Purulia 3) Biren Chandra Mahato (27 Yrs) S/O La Shakti peela Mahato Vill+PO Masina PS- Jhalda, Dist- Purulia 4) Rajen Kumar @ Hemanta Kumar (25 yrs) S/O Kartick Kumar of Vill- Lumpangli, PO - Pat Jhalda, PS- Kotahila Dist- Purulia and seized articles 1) One Tabla(Tangi) attached with bamboo handle length approx 3 ft 2) One axe attached with wooden handle length approx 2.5 ft 3) one sword made of iron with handle length approx 3 ft 4) one iron pipe length approx 3.5 ft 5) one iron rod length approx 2.5 ft 6) one nylon rope in red colour length approx 20 mtr 7) one bamboo stick length approx 4 ft 8) one bamboo stick length approx 3 ft lodged complain against them and 04 others to the effect that on 01.07.2021 at about 00:45 Hrs during my night mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled under a Mahuya tree situated at the foot of Sikara Hill near Railway level crossing at Jhalda Mauza and they were preparing themselves for committing dacoity at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 02 Dated 01.07.2021. On getting the tip off as per kind order myself accompanied with force who were detailed for the Night Mobile Duty with me namely C/-696 Gorupada Pal, C/-682 Mahadeb Rajak NVF/778 Samir Chandra Mahato, HG 1807 Shyam sing Laya all of Jhalda PS vide CC No. 1756 dated 30.06.2021 vide Jhalda PS GDE NO 1167 Dated 30.06.21 immediately proceeded to the anticipated place of assembly to work out the information and reached near Railway level Crossing at 01:15 Hrs leaving the Police vehicle No- WB 56C/8741 and started to proceed for the anticipated place on foot. At 01:25 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 10/12 persons assembled under a Mahuya tree situated at the foot of Sikara Hill 60 mtr away from the Jhalda-Barlanga main Road and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 04 (Four) of them at 01:45 Hrs while the rest 06/08 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to searched them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person 1) One Tabla(Tangi) attached with bamboo handle length approx 3 ft from the possession of Chinmoy Tiwary 2) One axe attached with wooden handle length approx 2.5 ft from the possession of Arjun Gorain 3) one sword made of iron with handle length approx 3 ft from the possession of Biren Chandra Mahato 4) one iron pipe length approx 3.5 ft from the possession of Rajen Kumar @ Hemanta Kumar 5) one iron rod length approx 2.5 ft 6) one nylon rope in red colour length approx 20 mtr from the possession of Chinmoy Tiwary. Then in between 01:45 hrs to 02:15 hrs on 01.07.21 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, I seized 1) One Tabla(Tangi) attached with bamboo handle length approx 3 ft 2) One axe attached with wooden handle length approx 2.5 ft 3) one sword made of iron with handle length


approx 3 ft 4) one iron pipe length approx 3.5 ft 5) one iron rod length approx 2.5 ft 6) one nylon rope in red colour length approx 20 mtr 7) one bamboo stick length approx 4 ft 8) one bamboo stick length approx 3 ft from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there with 08 others namely Bishnu Kundu of Danga, Jitu Kumar of Lupungdih, Barun Kuiry of old Jhalda, Naim Ansary of Bokaro and others for committing a house dacoity in a Maru family at Jhalda Town. I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Chinmoy Tiwary (23 yrs) S/O-Binod Tiwary of Vill- Danga PO- Jhalda PS- Kotshila, Dist-Purulia, 2) Arjun Gorain (22 yrs) S/O-Prabir Gorain of Pat Jhalda Road, Ward No 3, PS-Jhalda, Dist-Purulia 3) Biren Chandra Mahato (27 Yrs) S/O Lt Shakti pada Mahato Vill+PO Masina PS- Jhalda, Dist- Purulia 4) Rajen Kumar @ Hemanta Kumar (25 yrs) S/O Kartick Kumar of Vill- Lupungdi, PO - Pat Jhalda, PS- Kotshila Dist- Purulia along with 04 others namely Bishnu Kundu of Danga, Jitu Kumar of Lupungdih, Barun Kuiry of old Jhalda, Naim Ansary of Bokaro and others under proper section of law.
