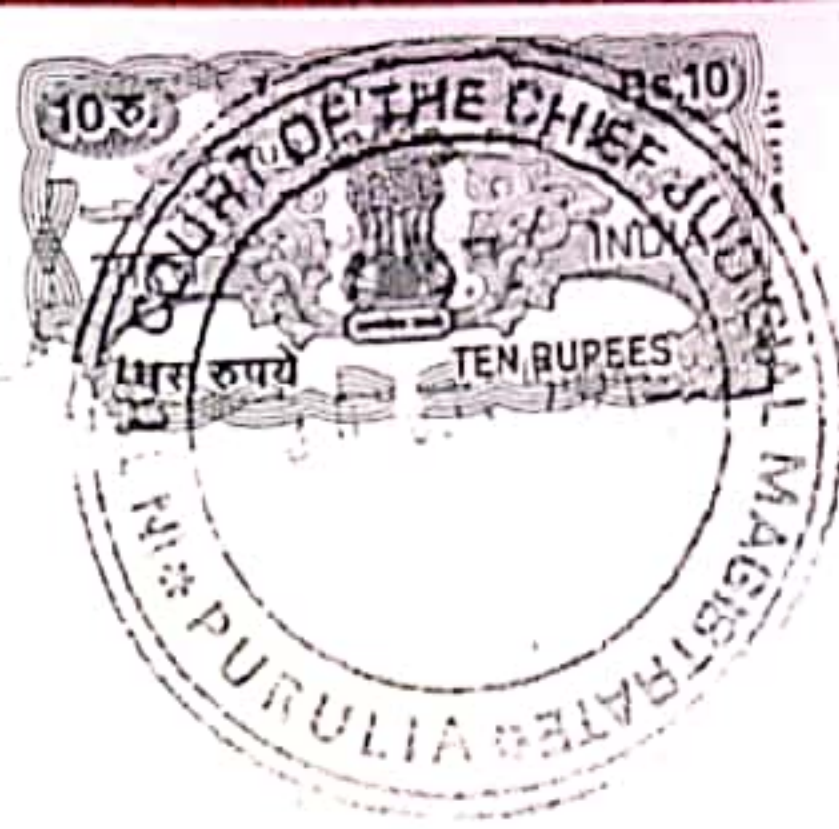

P.O.R-Nowadih, P.S. Jhalda, District Purulia and present accused ^{persons} are also the residents of Village Bisria, P.O.- R.Nowadih, P.S. Jhalda, District Purulia .

2...That sometime past the accused persons no.1 to 4 are behaving very roughly with the complainant and his family members and they used to threatened and uttered very filthy languages to the complainant and his family members. But the Complainant and his family members any how tolerated all such aforesaid trouble in order to avoid dispute and breach of peace.

3...That on 23.5.2021 corresponding to 8th Jaistha 1428 B.S., at about 10 A.M. when the Complainant and his wife were taking rests in their house suddenly the accused persons no.1 to 4 criminally trespassed the house of the complainant with greivous weapons such as Lathi, Kuthar, Iron rod etc. and appeared there and utter filthy languages to them, Complainant said to stop the mind, their filthy languages to the accused persons, But the accused persons were very furious, they encircled the son of the Complainant Chittaranjan Mahato. Tulshi Mahato ordered all accused persons to finish the life of Chittaranjan Mahato, ^{Bimal Mahato accused no. 2} Accused immediately assaulted Chittaranjan Mahato by Kuthar on the head of the Chittaranjan Mahato, ~~due to that assault Chittaranjan Mahato, due to that assault Chittaranjan Mahato~~ with common intention to murder, due to that assault Chittaranjan Mahato sustained heavy bleeding injury in his head and he fell down on the ground. Then Bijoy Mahato sat down on his chest and taking hands in neck of the Chittaranjan Mahato and put hesvy

pressure on the throat and neck of the Chittaranjan Mahato with intention to murder, the said Chittaranjan was at that time ~~in~~ dying condition ~~and~~ due to stangulation and low sound was coming from his mouth..Then other accused persons assaulted Chittaranjan Mahato by fists and blows and by legs. Complainant tried to rescued his son Chittaranjan Mahato accused no.1 Bijoy Mahato assaulted the complainant by Iron Road due to that assaulted Complainant sustained bleeding injury on his head complainant also fell down on the ground, then all accused persons assaulted him by fists and blows and by legs. and they also threatened to murdered the complainant. Complainant and his wife shouted for help. Hearing the halla, many villagers came there and saw the occurance. When many villagers gathered there then accused persons filed away from the place of occurance.

4...That thereafter the witnesses immediately took the injured Chittaranjan Mahato and complainant to Jhalda Police Station informed, the incident to I/C Jhalda, P.S. Jhalda Police sent the injured to Jhalda B.P.H.C. Hospital, for treatment. The complainant and Chittaranjan Mahato were treated as out door patient at Jhalda Pathardih BPHC

5...That accused persons are politically, influential person and still they are openly threatening the complainant and his family members .They also threatened to kill the complainant and Chittaranjan Mahato when they will get opportunity.

6...That the complainant was under the impression that police of Jhalda P.S. will start a police case against the accused

the accused persons, then the complainant informed the aforesaid incident to the S.P. Purulia inspite of that police of Jhalda P.S. are quite mum and has not started any police case, hence the present complainant is bound to filed this case.
